## Continuing Education for Manufactured Housing Installer License

HUD installer licenses expire every three years. Successful completion of a HUD-approved 8-hour continuing education course is required to renew an installer license. The course must be completed at least 60 days prior to the license's expiration date. If a HUD installer license expires, a new application must be submitted.

CMHA is offering the 8-hour in-person training and certification course *free* to CMHA members on **Wednesday, December 5, 2018**. In addition, members' guests will receive a discounted rate of \$50 per person. Tuition for non-members is \$200 per person. Registration is on a first-come basis.



The instructor is Mark Conte. His course has been approved by HUD. Mr. Conte has extensive experience in the manufactured housing industry. He has supervised all manufactured and modular housing production and placement in Pennsylvania, he developed the Pennsylvania installation programs for both new and relocated manufactured housing and modernized the modular housing program. He currently operates Manufactured Housing Compliance Services, a company that focuses on training manufactured home installers and building code officials.
